C.O.P.S.

Law Enforcement Officers put their lives on the line each day to protect the citizens of our communities. Each year, between 140-160 Officers are killed in the line of duty, and their families and co-workers are left to cope with the tragic loss. C.O.P.S. provides resources to help rebuild their shattered lives.

Families join C.O.P.S. through the tragic Line of Duty Death of their Officer. *There is no membership fee to join C.O.P.S., for the price paid is already too high!* 

C.O.P.S. was organized in 1984 with 110 individual members. Today, C.O.P.S. membership is over 54,000 survivors. Survivors include spouses, children, parents, siblings, fiance/significant others, and co-workers of Officers who have died in the line of duty according to Federal government criteria. C.O.P.S. is governed by a national board of survivors. All programs and services are administered by the National Office in Camdenton, MO. C.O.P.S. has over 50 chapters nationwide that work with survivors at the grassroots level. Concerns of Police Survivors, Louisiana Chapter is a 501(c)(3) non-profit organization.




## How can you help?
