### **ADDENDUM NO. 2**

Request for Proposal is hereby modified and clarified as follows:

### I. QUESTIONS FROM BIDDERS VIA EMAIL AND AT PRE-BID MEETING:

**A.** Question: For labor and mileage can we provide an hourly rate for labor and a separate price for mileage travel. You are currently asking for one hourly rate that included labor, mileage, equipment, lodging, etc.

Answer: No, rate is inclusive.

**B.** Question: Pages 4-5 and page 23 shows 20 gens, but page 38 shows 14. Please verify which list is correct.

Answer: Pages 4-5 and 23 are correct. There are 20 generators. However, a generator was recently added to the list for a new total of 21.

**C.** Question: We also visited this CAT 350kw Diesel generator. We were told that this generator is normally on a trailer but someone took it off of the trailer. Please confirm that we need to quote planned maintenance for this generator.

Answer: Yes. Regardless of if it is on a trailer or not, it will need to be maintained.

**D.** Question: Do we need to be a Licensed LA Contractor?

Answer: The company representative performing the work will need to be a licensed Electrician.

**E.** Question: Are you wanting a 2hr LBT to be performed with Full Service?

Answer: A load test for up to 2 hours starting at 25% to 80% load checking the transfer switch should be performed prior to the storm season as part of the full service.

**F.** Question: On pricing sheet Annual Cost for Maintenance- Should that be 3 inspections and a Full Service?

Answer: Routine maintenance shall be conducted once a quarter with an annual Full Service included within one of the quarterly routine maintenance services.

**G.** Question: 1. D. States "Normal maintenance shall also include any repairs/replacement required as a result of normal use"- at time of service when a repair is deemed necessary will that be treated as a quoted repair?

Answer: Normal maintenance repairs shall include belts, fluids, filters, and other items as required by the manufacturer. Minor repairs that are not a result of normal use will be paid as time and materials, cost plus 10%.
