GOVERNMENTAL FUNDS

REVENUE

The FYTD Revenue collected is \$28 million, 59% of the 2023 budget. Sales Tax Collections for the fiscal year are \$19.6 million, 92% of the budget for overall collections. This is \$1.3 million higher than FYTD collections for 2022.

EXPENDITURES

The operating expenditures incurred to date during fiscal year 2023 total \$17.6 million, 85% of the operating expenditure budget of \$20.7 million. Capital outlay to date is \$4.2 million, 33% of the Capital Outlay Budget.

ENTERPRISE FUND

REVENUE

The enterprise revenue for the fiscal year to date totals \$3.2 million, 88% of the operating revenue budget of \$3.6 million.

EXPENSES

The operating expenses incurred to date during fiscal year 2023 total \$2.8 million of the \$3.9 million budget, 72%, excluding depreciation. Capital Outlay to date is \$4.2 million, 77% of the Capital Outlay Budget.

The City currently has 112 active employees. We are always working to fill vacant positions.
