Agenda Item 1: Discussion of COLA increase for the Police and Non-Police employees of the City of Mandeville

Mr. McGuire made a motion to set a 3% COLA increase for Municipal Police Employees and to recommend to City Council a 3% COLA increase for Non-Police Employees for FY 25-26. The motion was not seconded; motion failed.

Dr. Carlson made a motion to set a 2.5% COLA increase for Municipal Police Employees and to recommend to City Council a 2.5% COLA increase for Non-Police Employees for FY 25-26. The motion was seconded by Mr. Ainsworth. *There being no further questions or comments, the motion passed* 5 - 0.
