**ORDINANCE NO. 21-30**

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MANDEVILLE AMENDING THE CODE OF ORDINANCES, CHAPTER 10, TO INCLUDE SECTION 10-73 AS A PROHIBITION OF PARKING OR TRAVERSING ON MEDIAN STRIP; DEFINITION; PENALTY; AND PROVIDING FOR OTHER MATTERS IN CONNECTION THEREWITH:**

**WHEREAS**, Louisiana Law grants to the legislative body of every incorporated municipality in Louisiana, including the City of Mandeville, general power to pass such ordinances not contrary to the Constitution of Louisiana or public general law as they may deem necessary in order to assure the good government of the municipality, to protect and preserve the municipality's rights, property, and privileges, to preserve peace and good order, to secure persons and property from danger and destruction, and to protect the health, comfort, and convenience of the citizens of the municipality; and

**WHEREAS**, Section 2-10 of the Charter of the City of Mandeville authorizes the City Council to pass ordinances as it may deem necessary for the good government of the City; for the protection and preservation of the City's property, rights and privileges; for the preservation of peace and good order; for securing persons and property from violence, danger or destruction; for the protection and promotion of the health, safety, comfort, convenience, welfare, and happiness of the residents of the City and for such other police or health matters as it may deem necessary;

**NOW, THEREFORE**, the City Council of the City of Mandeville, acting under and by virtue of the authority granted to it by Louisiana Law and Section 2-10 of the City Charter, does hereby adopt the following ordinance:

**IT IS HEREBY ORDAINED** by the City Council of the City of Mandeville that Chapter 10 shall read as follows:

**BE IT ORDAINED THAT SECTION 10-73 OF THE MANDEVILLE CODE OF ORDINANCES IS ORDAINED, TO READ AS FOLLOWS:**

**Section 10-73 Traversing or Parking on Median Strip Prohibited; definition; penalty**

- (a) Crossing, driving, stopping, standing or parking on any median strip, within the city limits of the City of Mandeville, other than for official use of maintenance vehicles, or the operation of emergency vehicles, is prohibited.
- (b) For purposes of this section, "median" shall be defined as the strip of land between lanes of opposing traffic on a divided highway.
- (c) Whoever violates the provisions of this section shall be penalized as provided in Section 1-9 of this Code.

**BE IT THEREFORE ORDAINED** that the City Council of the City of Mandeville hereby adopts and amends the provisions of this ordinance to be effective upon the Mayor's signature.
