ORDINANCE NO. 26-31

AN ORDINANCE OF THE CITY OF MANDEVILLE TO AMEND THE LANGUAGE OF SECTION 1 OF ORDINANCE 26-19

SECTION 1. The taxing district, which levied .34 mills in 2025, is requesting to roll forward from the adjusted millage rate of 3.13 mills to the maximum millage rate of 3.38, but not in excess of the prior year's maximum rate, on all taxable property shown on the official assessment roll for the year 2026, and when collected, the revenues from said taxes shall be used only for the specific purposes for which said taxes have been levied.
