ORDINANCE NO. 26-33

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MANDEVILLE TO EXECUTE AMENDMENT NO. 6 TO ORDINANCE NUMBER 25-25, THE OPERATING BUDGET OF THE CITY OF MANDEVILLE AND FOR OTHER MATTERS IN CONNECTION THEREWITH (YEAR END)

WHEREAS, Article B. Financial Procedures of the Home Rule Charter provides that amendments to the adopted budget be made by ordinance; and

WHEREAS, amendment No. 6 to the Operating Budget adopted for fiscal year 2025-2026, Ordinance Number 25-25, is necessary to incorporate end-of-the year budgetary adjustments, including alignment of budgeted revenues with actual receipts from grants and authorized transfers between City funds; and

NOW, THEREFORE BE IT ORDAINED by the City Council of the City of Mandeville that the Operating Budget ordinance for fiscal year 2025-2026, Ordinance Number 25-25, is hereby amended to include budget amendment No. 6 (Year End Adjustments) as set forth on the attached Exhibit "A" incorporated as a part hereof, and be adopted for the 2025-2026 Fiscal Year Operating Budget.

BE IT FURTHER ORDAINED, that in all other respects the 2025-2026 Operating Budget adopted shall remain in full force and effect.

The Ordinance being submitted to a vote, the vote thereon was as follows:

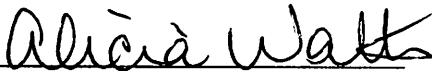

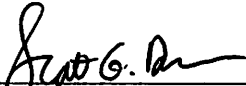
