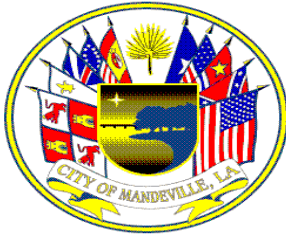

REINSPECTION FEES (5.1.9): The required inspections shall be included as a part of the permit fees listed herein unless specified differently. However, if a permit holder calls for an inspection and the work inspected does not meet code or requires a second or subsequent inspection, a reinspection fee in accordance with the following sliding scale shall be submitted prior to reinspection:

- a. 1st Reinspection – forty (\$40) dollars
- b. 2nd Reinspection – eighty (\$80) dollars
- c. 3rd Reinspection – one hundred twenty (\$120) dollars
- d. 4th Reinspection – two hundred forty (\$240) dollars
- e. 5th Reinspection – Citation and “Stop Work” order issued
